THIS WAS DONE AT THE REQUEST OF CHIEF MEDICAL EXAMINER CORONER LAKSHMANAN SATHYAVAGISWARAN, M.D. THE CORONER REQUESTED THAT MR. JACKSON'S BODY BE TRANSPORTED BY HELICOPTER DUE TO THE TRAFFIC CONGESTION THAT WOULD OCCUR IF HE WAS TRANSPORTED BY GROUND AMBULANCE.

FROM TIME TO TIME THE LOS ANGELES COUNTY CORONER REQUESTS THAT THE SHERIFF'S DEPARTMENT TRANSPORT DECEASED INDIVIDUALS FOR SAFETY AND SECURITY REASONS.
