I hereby release CPT, KCBS-TV, CBS Corporation, and the Grantees from any and all claims that I may hereafter have against CPT, KCBS-TV, CBS Corporation, and/or the Grantees, whether for violation of any right of privacy, publicity, defamation, emotional distress or any other claim of any kind or nature, in connection in any manner with the rights I am granting herein.
