DODD, JERRY OAK JR. ___ 7577, A FELLOW PEACE OFFICER OF THE CITY OF DALLAS, DALLAS COUNTY, TEXAS, WHO PERSONALLY PARTICIPATED IN THE INVESTIGATION OF THESE ALLEGED OFFENSE(S), PROVIDING THIS INFORMATION TO AFFIANT, AND WHOSE INFORMATION AFFIANT BELIEVES TO BE CREDIBLE.

ON AUGUST 01, 2007 AT ABOUT 0250 P.M. OFFICER(S) DODD, JERRY OAK JR. # 7577 AND DURICA, DAVID A # 5085 EXECUTED ARREST WARRANT AT 8051 LBJ FRWY DALLAS, DALLAS COUNTY, TEXAS.

ON 08/01/07 AT ABOUT 2:50 P.M. NORTHEAST DEPLOYMENT OFFICERS J. DODD #7577, D. DURICA #5085, F. POBLENZ #2953, L. CODDINGTON #6830, D. NEVITT #4517, AND SGT. R. SUNDQUIST #6517 WERE EXECUTING A FELONY WARRANT FOR AP HANNON AT 8051 LBJ FRWY. AD NEVITT OBSERVED AP HANNON EXIT THE REAR ENTRANCE TO THE HOTEL, AT WHICH TIME AP WAS CARRYING A BLACK LEATHER BAG. AP HANNON OBSERVED AOS IN THE PARKING LOT AT WHICH TIME HE IMMEDIATELY DROPPED THE BLACK BAG AND TOOK EVASIVE MEASURES BY RAPIDLY WALKING SOUTHBOUND THROUGH THE PARKING LOT. AOS DODD AND DURICA TOOK AP HANNON INTO CUSTODY, AS HE BEGAN TO WALK WESTBOUND ON THE SERVICE RD TO LBJ FRWY. THE DRUGS WERE WEIGHED BY AD DURICA.

THE DRUGS WERE PLACED IN THE LEW STERRETT LOCK BOX BY AD DODD ON TAG NUMBER 133935. AD DODD ALSO RECOVERED A COLT 357 CALIBER REVOLVER #6047CK FROM THE BAG IN WHICH AP HANNON WAS CARRYING.
